LIVING WAGE

RWF 215,096 (USD 188)

This report updates the Anker Living Wage Reference Value for rural Rwanda to June 2023. The living wage reference value was originally estimated at RWF 147,111 (USD 160) in 2020². The updated value takes into account the inflation accumulated in the country from June 2020 to June 2023 (48%)³. The value updated to 2023 is RWF 215,096 (USD 188), and comprises a net living wage of RWF 165,469 (USD 144) and social security and income tax payments for RWF 49,627 (USD 43).⁴ Without accounting for inflation, the living wage estimated in 2020 would not be sufficient for workers and their families to have a basic but decent standard of living in 2023, because the purchasing power of the living income would have decreased.
