

ANKER REFERENCE VALUE ANNUAL UPDATE 2023¹

URBAN GUATEMALA

LIVING WAGE

GTQ 4,800 (USD 612)

This report updates the Anker Living Wage Reference Value for urban Guatemala to 2023. This was GTQ 4,646 (USD 603) for 2022 in the original report², comprised of a Net Living Wage of GTQ 4,401 (USD 571), plus a social security contribution of GTQ 245 (USD 32). The updated Anker Gross Living Wage for 2023 is GTQ 4,800 (USD 612) per month, comprised of a Net living Wage of GTQ 4,540 (USD 579), plus GTQ 260 (USD 33) in mandatory pay deductions which would need to be paid by law as a contribution to the state health fund (4.83%) and income tax (5%). It is worth noting that a worker's contribution to social security (4.83%) is considered as a deductible expense for income tax purposes and in addition there is a GTQ 4,000 monthly deduction³. Inflation in this period was 3.2%⁴ and it increased the Net Living Wage. Without accounting for inflation, the Living Wage estimated in 2022 would not be sufficient for families to have a basic but decent standard of living in 2023, because the purchasing power of the Living Wage would have decreased. Mandatory deductions were calculated using the most up-to-date tax laws.⁵
