

## ANKER REFERENCE VALUE ANNUAL UPDATE 2023<sup>1</sup>

## **RURAL PANAMA**

## **LIVING WAGE USD 610**

(PANAMA is a dollarized country)

This report updates the Anker Living Wage Reference Value for rural Panama to 2023. The updated Anker Gross Living Wage for 2023 is USD 610<sup>2</sup> per month, comprised of a Net Living Wage of USD 543, plus a contribution to social security and educational insurance of USD 67. The Gross Living Wage was USD 569 for 2020 in the original Reference Value report,<sup>3</sup> comprised of a Net Living Wage of 513 USD plus a social security contribution of USD 56. Inflation in this period was 5.8%<sup>4</sup> and it increased the Net Living Wage. Without accounting for inflation, the Living Wage estimated in 2020 would not be sufficient for families to afford a basic but decent standard of living in 2023, because the purchasing power of the living wage would have decreased. Social security contributions and income tax were calculated using tax laws in force in June 2023.<sup>5</sup>
